**Public Hearing – RDA –** Submitted by Vincent & Amy Caruso, 117 Vine St., map 16C lot 30, regarding the addition of a floating dock extension & 2 jet ski lifts, all within the BZ of Otis Reservoir. With all the being said, Dave made a motion of a -3 determination with standard conditions. DB 2nd the motion and the Commission voted unanimously to issue a -3 determination.

**Public Hearing – RDA** – Submitted by Deborah Kane, 47 North Lake Ave., map 18A lot 37, regarding the removal of an 80 ft rotting oak tree & 2 pine trees, all within the BZ of Otis Reservoir.
