# **PUBLIC HEARINGS:**

**Public Hearing – RDA –** Submitted by Francisca R. Heming - MassDOT Highway Division, Route 8, MM near MM 10.00, regarding drainage repairs along Route 8, all within the 100' RFA of West Branch Farmington River, BZ, BLSF & Estimated & Priority Habitat. MASSDOT had a representative at the meeting to explain the repairs. After explanation from the representative and discussion of the repairs with the Commission, Dave made a motion of a -3 determination with standard conditions. CC 2nd the motion and the Commission voted unanimously to issue a -3 determination.

**Public Hearing – RDA** – Submitted by Marc Bergeron, 81 Vine St., map 16C lot 21, regarding the installation of docks & boat lift, all within the BZ of Otis Reservoir. Mark Bergeron was at the meeting to represent himself. After discussion between the applicant and the Commission the applicant decided to withdrawal his application and he will submit an NOI for next month's meeting.

**Public Hearing – RDA –** Submitted by Fred Sears on behalf of Patricia Walker Trustee, 245 D'Wolfe Dr., map 7A lot 57, regarding the replacement of existing septic system & new well, all within the BZ of Watson Pond. Fred Sears sent out a representative to discuss the project. After discussion between the representative and the Commission, Dave made a motion of a -3 determination with standard conditions and to make sure a silt fence is put in place prior to the start of the job. CC 2nd the motion and the Commission voted unanimously to issue a -3 determination.

**Public Hearing – RDA** – Submitted by Herbert Eichstedt, on behalf of Henry Devault, 98 Telephone Rd., map 7B lot 19, regarding the replacement of rotting deck boards with new deck boards, all within the BZ of White Lily Pond. After discussion amongst the board in regards to the project, Dave made a motion of a -3 determination with standard conditions. JL 2nd the motion and the Commission voted unanimously to issue a -3 determination.
