Master Plan- Using the action plan section of the Town of Otis Master Plan, 2016, The committee reviewed the progress on various initiatives, including community engagement, infrastructure improvements, housing, and environmental conservation efforts. They discussed the status of these initiatives. During this discussion, the various initiatives were categorized as ongoing projects, completed tasks, or areas for further progress across multiple domains such as transportation, historical preservation, and recreational facilities. The committee also considered the potential for new projects and funding sources, emphasizing the need for collaboration and communication with town officials, established boards and commissions concerning the development of long-term plans for the town's growth and sustainability.

Various town initiatives related to transportation and infrastructure were discussed. The committee noted recent accomplishments, including new sidewalk installations and wildlife crossing signage.
