East Otis Schoolhouse Project: Based on a successful bid round the Architect is recommending awarding this round of work to Larochelle Construction Inc. The Board unanimously approved. Brandi will send the award letter in the morning and have the contract for the Chair to sign after the terms are added in.

Town Caucus: Gary read aloud the caucus call for April 15th at 7pm. The Board will all sign.

Annual Town Election: In response to the RDA passing Lyn will need a letter from the Board to remove the School Committee spot from the ballot. The Board unanimously approved. Brandi will draft the letter.

Forest Management Plan: DCR is requiring an updated plan. There is only 5% of the timber remaining to be cut. The Board was good with the updated plan and unanimously approved. The Board will sign.
